CITY OF TONTITOWN, WASHINGTON COUNTY, ARKANSAS

A RESOLUTION WAIVING COMPETITIVE BIDDING AND AUTHORIZING THE PURCHASE OF ONE (1) 2022 FORD F450 REGULAR XL, 4X4, 7.3L TRUCK AND SNOWDOGG TE90 SNOWPLOW WITH RELATED EQUIPMENT FROM GRAND TRUCK EQUIPMENT CO, LLC. FOR THE CITY OF TONTITOWN, ARKANSAS.

WHEREAS, the City of Tontitown received a quote from Grand Truck Equipment Co., LLC for one (1) 2022 Ford F450 Regular XL, 4X4, 7.3L Truck and SnowDogg TE90 Snowplow with related equipment in the amount of approximately \$80,089.00;and

WHEREAS, the City Council has reviewed the quote provided by Grand Truck Equipment Co., LLC., attached hereto as Exhibit “A”, and believes the price and availability for one (1) 2022 Ford F450 Regular XL, 4X4, 7.3L Truck and SnowDogg TE90 Snowplow with related equipment to be advantageous; and

WHEREAS, because the quote provided by Grand Truck Equipment Co., LLC is only valid for a limited amount of time, and the City Council believes that this price is advantageous and will not be available in the future, the City Council has determined that an emergency exists which necessitates the waiver of competitive bidding; and

WHEREAS, the City Council has determined it is in the best interest and benefit to the community to authorize the Mayor to purchase one (1) 2022 Ford F450 Regular XL, 4X4, 7.3L Truck and SnowDogg TE90 Snowplow with related equipment from Grand Truck Equipment Co., LLC., for the amount of approximately \$80,089.00, and to waive competitive bidding for the same in order to provide reliable equipment for the safety and welfare of the City of Tontitown.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Tontitown, Arkansas:

Section 1. Competitive bidding is hereby waived and the quote secured by the Mayor of Tontitown for the purchase of one (1) 2022 Ford F450 Regular XL, 4X4, 7.3L Truck and SnowDogg TE90 Snowplow with related equipment from Grand Truck Equipment Co., LLC. in the sum of approximately \$80,089.00 is hereby approved.

Section 2. The Mayor and her designee are hereby authorized to expend said funds and to take all such other action as is necessary in connection therewith. Further, all previous actions of the Mayor or her designee in connection therewith are hereby approved and ratified.
