- 3. Senate Bill 197 is a Airbnb's are short term rentals but there is a Bill to remove the ability to regulate those short term rentals and this has raised issues with different cities that have problems with them with regard to the location and what they can or cannot do.
- 4. Senate Bill 296? was filed on the school side and possibly filed on the city's side, this is a Bill to attempt to make all City elections along with school election, partisan. This is consistently fought by the Municipal League in cities who don't want a part of partisan politics and city elections or school elections but if this one comes up, he will let the city know.
