**Section 1.** The City Council hereby authorizes the City of Tontitown to issue a request for qualifications for engineering and planning services.


**Section 2.** The Mayor and her designee are hereby authorized to take all such action as necessary in connection therewith.

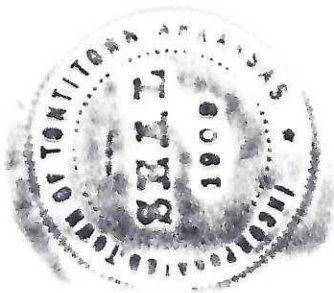
