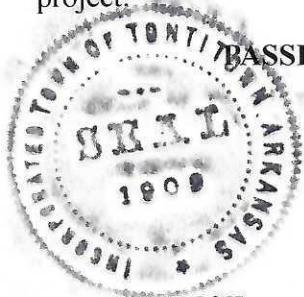
**WHEREAS**, this project, using federal funding, will be open and available for use by the general public and maintained by the applicant for the life of the project; and
