

ORDINANCE NO. 2023-11) - 1082

CITY OF TONTITOWN, WASHINGTON COUNTY, ARKANSAS

AN ORDINANCE TO REZONE APPROXIMATELY 1.5 ACRES OF REAL PROPERTY LOCATED AT WASHINGTON COUNTY PARCELS #830-37903-900 AND #830-37902-200 FROM RESIDENTIAL ESTATES (R-E) TO SINGLE FAMILY RESIDENTIAL (R-1) IN THE CITY OF TONTITOWN, ARKANSAS.

WHEREAS, a Public Hearing was held before the Planning Commission for the City of Tontitown, Arkansas to hear public input to the question of an application to rezone approximately 1.5 acres of real property located at Washington County Parcels #830-37903-900 and #830-37902-200 in Tontitown, Arkansas from Residential Estates (R-E) to Single Family Residential (R-1); and

WHEREAS, after due notice as required by law, the Tontitown Planning Commission has, at the time and place mentioned in the notice, heard all persons desiring to be heard on the question and has ascertained that the rezoning requested should be approved and has recommended approval to the Tontitown City Council; and

WHEREAS, the Tontitown City Council has determined that the public interest and welfare is best served by approving the requested rezoning.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Tontitown, Arkansas:

<u>Section 1</u>. The City of Tontitown hereby changes the zone classification from Residential Estates (R-E) to Single Family Residential (R-1) for approximately 1.5 acres of real property located at Washington County Parcels #830-37903-900 and #830-37902-200, more particularly described in the attached Exhibit "A".

Section 2. Any ordinances or parts of ordinances in conflict with this ordinance are hereby repealed to the extent of the conflict.

Section 3. In the event any one of more of the provisions contained in this Ordinance shall for any reason be held by a court of law to be invalid, illegal or unenforceable in any respect, such invalidity, illegality or unenforceability shall not have an effect on the remaining provisions

of this Ordinance, and this Ordinance shall be construed as if such invalid, illegal or unenforceable provision or provisions had never been contained herein.

Section 4. The official zoning map of the City of Tontitown, Arkansas is hereby amended to reflect the zoning change provided in Section 1 hereof.
