Re: Hwy 412 – Hwy 112 Water and Sewer Relocations

Dear Mr. Clark:

Due to ArDOT's upcoming construction of Highway 612 from Old Highway 68 west of Tontitown to Highway 112 south of Cave Springs, the City of Tontitown must relocate several sections of water and gravity sewer lines that will be in conflict with the highway construction. An exhibit indicating the locations of the relocations is attached to this letter, as is a conceptual-level estimate of construction costs with breakdowns of reimbursement rate and non-construction costs.

At this stage, we estimate that the construction cost will be around \$3.73 million, with total project costs estimated to be around \$4.18 million. It is anticipated that Tontitown will ultimately be responsible for roughly \$37,607, which is 0.90 percent of the total cost, with ArDOT reimbursing the City for the remaining 99.10 percent.

The fee for professional services associated with this project is estimated to be \$285,000, which includes project management and administration, surveying (including preparation of easement acquisition documents), design, environmental services, and bidding. We request that the City Council authorize Garver to proceed with this this work.


