B. Discussion of a Resolutions authorizing the submittal of an application for Arkansas Community and Economic Development Program Grant -Chamber Springs — Angie/ James Clark —

James Clark has been working with Cassie Elliott who has done a lot of work in the last 20 years with small communities to help residents receive better quality water services. Mrs. Elliott presented to the council a power point and samples of their well water she and 20 other residents in Chamber Springs are experiencing. Tontitown has a water line closest to Chamber Springs and is hoping to be able to hookup to that water line.

High contaminants levels of oil, grease, Sulphur, and coliform have been Identified, some residents have a filtering system, but the water is still not fit to drink or even bathe, and not everyone can afford a filtering system due to the cost.

Charla Reed and Matt Reed both of Chambers Springs showed the council a sample of the filtered water from Matt's well and Charla said illness has been reported.

Mrs. Elliott is looking to apply for grants and James Clark said there is no cost to the city other than maintaining the water line.

E. Discussion of a Resolution - Highway 612 Water and Sewer Relocation- Angie/James Clark

The city has received a proposal from Garver, LLC, the total cost associated with this project is estimated to be approximately \$4,178,550.00, however, the City of Tontitown will only be responsible for \$37,568.00, which is 0.90 percent of the total cost, with ARDOT reimbursing the city for the remaining 99.10 percent.

- 3. The Foundation Meeting has been rescheduled for March 11th at 6:00 pm, in chambers.
- 4. Air test results from the National Guard, two chemicals were found Benzene and Acrolein and to the mayor's understanding there is to be more testing.
