

**ORDINANCE NO. 2025-\_\_\_\_\_**

**CITY OF TONTITOWN, WASHINGTON COUNTY, ARKANSAS**

**AN ORDINANCE AMENDING SUBPART (R) OF CHAPTER 155.01: FEES OF THE TONTITOWN MUNICIPAL CODE; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES.**

**WHEREAS**, the City Council of the City of Tontitown has adopted regulations to establish a fee schedule for use by the City of Tontitown, which is codified in Chapter 155.01: Fees of the Tontitown Municipal Code; and

**WHEREAS**, it has become apparent to the City Council of Tontitown that a need exists to amend subpart (R) of Chapter 155.01: Fees in order to update the permit fee for the outdoor food vendor annual fee, as reflected below; and

**WHEREAS**, the Tontitown City Council has determined that it is in the best interest and benefit to the community to amend subpart (R) of Chapter 155.01: Fees of the Tontitown Municipal Code, as set forth below.

**NOW THEREFORE, BE IT ENACTED**, by the City Council of the City of Tontitown, as follows:

**Section 1.** That subpart (R) of Chapter 155.01: Fees of the Tontitown Municipal Code is hereby amended as follows:

(R) *Outdoor food vendor.* One hundred fifty dollars (\$150.00).

**Section 2.** The rest and remainder of the Chapter 155.01 not specifically amended herein remains in full force and effect.

**Section 3.** In the event that any section, paragraph, subdivision, clause, phrase, or other provision or portion of this Ordinance shall be adjudged invalid or unconstitutional, the same shall not affect the validity of this Ordinance as a whole, or any part or provision, other than the part so decided to be invalid or unconstitutional, and the remaining provisions of this Ordinance shall be construed as if such invalid, unenforceable or unconstitutional provision or provisions had never been contained herein.

**Section 4.** Declaration of Emergency. It is hereby found and determined that subpart (R) of Chapter 155.01: Fees of the Tontitown Municipal Code should be immediately amended in its entirety in order to update the amount of the annual fee for outdoor food vendors in the City of Tontitown. Therefore, an emergency is declared to exist, and this act, being immediately necessary for the preservation and protection of the public peace, health, safety and welfare of the City and its citizens, shall become effective on the date of its passage and approval by the Mayor.
