- Design of the Community Building
 - Design of Play Structures for Two Separate Grants
 - Design of the Intersection and Pedestrian Improvements at Hwy. 412 / Barrington Road

This will be an "open house" meeting with no formal presentations. Project design teams and city representatives will be available to discuss project specifics, answer questions, and receive public comments. For all projects, various project documents will be available for the public to view including plans showing proposed improvements and anticipated project schedules. For the Hwy. 412/Barrington Road Intersection and Pedestrian Improvements, the potential impacts to neighboring properties will be discussed including minimal or de minimis impacts to Harry Sbanotto Park (protected under Section 4(f) of the DOT Act), and visual changes near the 1920 Tontitown School Building (protected under Section 106 of the National Historic Preservation Act).
