**WHEREAS**, the City of Tontitown has completed the design of the half street improvement project along Mantegani Road and has found that a sewer force main is in conflict with the proposed street improvements; and

**WHEREAS**, the City has received a proposal from Kennett Underground, LLC in the amount of \$24,499.50 for the relocation of the sewer force main, and the City finds that Kennett Underground, LLC is qualified to perform the scope of services set forth in the attached Exhibit "A"; and

**WHEREAS**, the City has reviewed the quote provided by Kennett Underground, LLC, attached hereto as Exhibit "A", and has determined that it is in the best interest and benefit of the community to authorize the Mayor to negotiate and execute a contract with Kennett Underground, LLC in the amount of \$24,499.50, attached hereto as Exhibit "A", to relocate the sewer force main in conflict with the necessary street improvements project in the City of Tontitown.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Tontitown, Arkansas:

**Section 1.** The Mayor is hereby authorized to negotiate and execute a contract with Kennett Underground, LLC in the amount of \$24,499.50, attached hereto as Exhibit "A", for the relocation of a sewer force main in conflict with the Mantegani Half Street Improvements Project.
