A. Museum

Tontitown Historical Museum (THM) Report for the COW Meeting Tuesday, October 21, 2025

The THM Board of Directors met on October 6, 2025, at City Hall.

1. Springdale Schools Collaboration: Museum staff are working with Helen Tyson Middle School as well as Walker Elementary School to create new Discovery Boxes for the museum to loan out and take to off-site events. Students have chosen to focus on the Traditions and Events of Tontitown. We are excited to see what the students create and to work with them through our archives and artifacts.

2. Digitization Project: Currently Juli is preparing our online catalog to be launched early next month. She is cleaning up entries already in CatalogIT and we have beta testers checking entries for us to ensure the website is easy to navigate and sending feedback. We are excited to share the catalog with our visitors, researchers and those generally interested in Tontitown history, this will give our museum national reach through personal computers and cellphones.

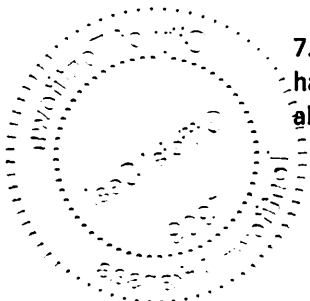
3. Visitors: September Visitors: 55 including the Wild & Unstructured Home School Group; 2024: 40

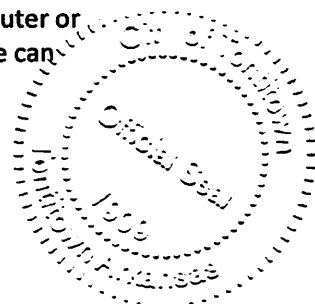

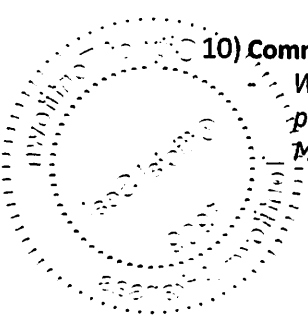

- Mr. Wagner submitted a written comment and only 1 page was entered out of 10 so Mr. Wagner asked that it be corrected.
- In regard to the public comment, I wish to make tonight, I emailed all the council on 10/08/25 some outlines of what seems to be an illegal exaction. Your attorney who sits here tonight has billed the city, for two meetings a month, from January through June. and appeared once. An attorney I talked to says that's a form of illegal exaction, which you may be familiar with because the lawsuit that has just been settled evolved around that. I provided the clerk with a proposed resolution asking the council to seek reimbursement for \$13,500. I do so because when the other illegal exaction suit was brought, I spoke for several months asking for the council to take action. I'm doing so again in a little more formal fashion and would hope that y'all would see the wisdom in doing that. I've also advised the legislative audit session that will be in your 2025. So perhaps they'll bring this up again, but I think if you'll be proactive, it might be considered a little bit better than what was wrote in your last order. as you know, there's a lawsuit pending on FOIA. at this point, I guess Mr. Eichmann is still your attorney of record and whether or not he's going to intend to continue. Not sure how that's going to shape out, but we have requested some deposition dates and I believe Mr. Eichmann's going to be on vacation or something. So, we're wanting to move forward on this and hope you people have your council picked out, whoever it may be, it's going to represent us in that suit Thank you.

Kenneth Lovett 18702 Clearwater Rd, Fayetteville, AR

- NWA Council Chair Doug Sprouse came here four years ago to push a landfill expansion. We don't need a road into the landfill. We need the landfill closed due to the hazards that continue to expose citizens. Has the council ever consulted any environmental air quality engineers? I haven't heard that they have. They're called air quality scientists, air quality specialists, air quality analysis, air quality technician, air quality inspector, air quality consultant. As the council, as far as I know, has never consulted with one and I don't believe any of us in this room are environmental engineers. If Tontitown does not get a proper air quality expert to look over tests done by CEDA and ADQ, you're negligent. You're still exposing people every day. Deciding to build new roads to Waste Management instead of addressing the real issues. I don't know after years of hearing issue after issue why you'd continue to do that. Mr. Latham stood here two weeks ago and stated, "You need to stop all litigation and talk to Waste Management." We did that first. What good did it do? Monday 10:205 at 7:35 a.m. There was an unknown smell. There needs to be a lot of attention paid to things that are going on in this city. I'll send y'all this email. Thank you

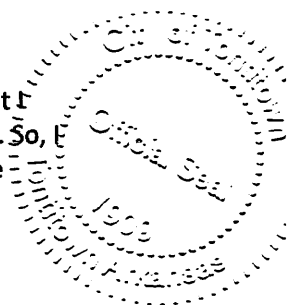
- I appreciate everybody coming out.

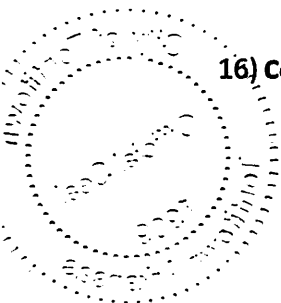
15) Comments from Mayor
