**A RESOLUTION TO WAIVE COMPETITIVE BIDDING AND AUTHORIZE THE PURCHASE OF ONE (1) 2025 CHEVROLET TRUCK TAHOE FROM SUPERIOR AUTOMOTIVE GROUP FOR THE TONTITOWN POLICE DEPARTMENT.**

**WHEREAS**, the City of Tontitown has received a quote from Superior Automotive Group for one (1) 2025 Chevrolet Truck Tahoe and related equipment in the amount of \$72,236.33; and

**WHEREAS**, the City Council has reviewed the quote provided by Superior Automotive Group, attached hereto as Exhibit "A", and believes the price and availability for one (1) 2025 Chevrolet Truck Tahoe to be advantageous; and

**WHEREAS**, because of the availability of certain makes and models of vehicles appropriate for police department use has been severely limited, and the City Council believes that the price is advantageous and will not be available in the future, the City Council has determined that an emergency exists which necessitates the waiver of competitive bidding; and

**WHEREAS**, the City Council finds it to be in the best interest and benefit of the community to authorize the purchase of one (1) 2025 Chevrolet Truck Tahoe in the amount of \$72,236.33, attached hereto as Exhibit "A", from Superior Automotive Group for the Tontitown Police Department, and to waive competitive bidding for the same.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Tontitown, Arkansas:

**Section 1.** Competitive bidding is hereby waived, and the City Council hereby authorizes the purchase of one (1) 2025 Chevrolet Truck Tahoe from Superior Automotive Group in the amount of \$72,236.33, attached hereto as Exhibit "A".

**Section 2.** The Mayor and her designee are hereby authorized to take all such action as necessary in connection therewith.
