7. Comments from Citizens

Kenneth Love 18702 Clearwater Road, Fayetteville, AR

- I'm here because of the continuing chemical vapors from waste management. There's a quote that says, "Silence is easier than confrontation. It is better to be silent than to dispute with the ignorant." Silent cut off is better than confrontation, less stress, less manipulation, and less action but you don't get nothing done if you're silent. Nothing that has been done by the city to address hazardous vapors emitted to Waste Manage from Waste Management every day into our community. The mayor, with approval by city council pursued the denial of the class one and class 4 expansion permits. The council unanimously approved the resolution for denial of future expansions, but the city, as a whole has done nothing to address the vapors emitted from Eco Vista Waste Management. This has to be addressed, and it needs to become from the city in the form of an Arkansas approved regulation that are written and the regulations and followed by the ADQ. Third party rulemaking must be written then approved through the governor's office and legislature. The third party should be the whole city of Tontitown, Arkansas, driven by a knowledgeable environmental engineer that has discussed the issues with the exposed citizens and has done the proper due diligence in the area and laid out the process and plan to the citizens council and mayor before reaching out to the Arkansas government to work through the process. In my opinion, this needed to start four years ago, Tontitown needs an environmental professional to work with the council and the mayor to address the landfills emissions. Specifically, Tontitown needs to do a third-party request for revisions to regulation 22 to address specific criteria of hazardous chemicals that are affecting everyone in the area. No total VOCC blend percentage rate accepted, there should be specific values for hazardous chemicals being emitted into our community every day to our children, grandchildren, youth, families, elderly, and while Waste Management continues to improperly operate and expose us slowly. We need to get someone who will listen, not just blow us off. Mark Laam started this process with the Tontitown Air Committee and a few others but then stopped because he didn't like the way I approached things, and he decided he could fix everything by talking to Waste Management. How'd that work out for Tontitown? There is no talking with Waste Management. They only talk to tell you what their stipulations will be, and you accept them or you move on. When I talked with Chief Krug, he said, "We all need to move." What has the chief done with the \$1,500 sampling kit for the air test? Does anyone in the Fire Department know how to use it? Are the collection tubes up to date? Why is there no hazardous vapor emergency response in the area for that responds immediately when vapors are in the area? Where is Washington County Department of Emergency Management? Why are they only for storm damage? Where is Arkansas Emergency Management? Why does everybody point to AD ADQ while ADQ pockets millions without proper response or training? Councilman Danny Montes keeps trying to push an agenda that makes no sense to me. He forwards city business by email to citizens that has no connection with the city government other than causing turmoil and administrative overkill. Thank y'all.

- I'd like to say something positive. The horrible smells that we have been exposed to coming out of the lift station seem to have dissipated better. It's not as bad as it was. It's been about three weeks or so, and I think that's probably when you guys brought them on. Yes, there's head nodding back here. At any rate, I don't know what's caused the change, something has. It's not as bad as it was. Occasionally, we get a whiff, but I hope it continues and we are able to breathe in our backyards and enjoy being outside with our friends and family. So, someone out there is doing a good job and I appreciate it. Thank you.

Mark Calcagni 12642 Abor Acres Road, Tontitown, AR

- I'm here today is I want to tell you about pediatrician epidemiologists. That's a hard word. His name is Philip Landrigan, he's one of the friends with Steve Unger. He examined both air tests, all four air tests. I'm going to read it as fast as I can. He says these reports main finding of the Tontitown air sampling study done in May that two components benzene acryline and a third ethylbenzene were identified as having contributions likely to the landfill and in all of his nine compounds. He says, "Nowhere does the September 8th report note the well-established fact that benzene is a proven human carcinogen that is strongly linked to excessive occurrence of leukemia and lymph. Infants in the womb and young children are especially at risk. But the plain fact is this is his email; the plain fact is that there is a health hazard there. And now it may take many years for cases of leukemia to develop in exposed children. It would therefore be wise to take measures to reduce benzene and acryline exposure now and not wait for a tragedy to happen. We just had a recent well water test close to the landfill, and he also examined this test. He said these results are very clear and speak for themselves. They showed that three members of the family of Perfluoroalkyl and polyfluoroalkyl substances (PFAS) or forever chemicals. This specific set of compounds represents the fingerprints of PFAS forever chemicals associated with landfill as opposed to those associated with industrial sites, airports or military. What this says to me is that Tontitown Landfill is leaking hazardous and carcinogen PFAS compounds and potentially other toxic chemicals into groundwater. In addition to the toxicities listed in the attached note, the World Health Organization has determined that PFAS compounds are associated with testicular cancer. Kind of like what everybody's been saying here. You know, three of us, the two of us, have talked about the landfill. We're just hoping that we can do something. Have we done everything we possibly can? That's what my question is tonight. And if you feel good about your legacy here in Tontitown, I hope you do. And I hope it's something that maybe you look at the health and safety of our citizens. Thank you

- I'm coming from my heart. I'm no scientist, but we continue to need our help. Your help. I know you're all smart and you can dig deep and you've done everything in your ability to help us. And yes, the lift station is better, but it's not gone away. And they keep piping more and more, and I still feel like they control it somehow, some shape or form when there's any kind of testing or anybody around, they can make it better. I understand our city's in negotiation with them and I hope that continues. I hope we can get an avenue where something can be worked out. I know a lot of this is beyond you, it's through state legislation, rules, regulations. One concern I have on the agenda is we're consulting about this leachate and the biggest word that shows up is the odor. I just hope if we spend all this money for this consult that not only are we taking into the account the odors but this chemical vapors that are appearing and showing up because we really have the two different problems the sewer lift and Waste Management itself and I hope that's addressed and I So, it's going to take a lot to be able to change any kind of rules and regulations, but I hope that all of you dig deep and do homework, pull out everything you can to help our community, because Tontitown has

been here so long, it's a beautiful history, it's a beautiful little city and I don't want us to leave a legacy of not being good stewards for the land. Thank you for your time and especially thank you for our Street Department. They did a wonderful job keeping us all safe and sound in this snow. And thank you all.
