

RESOLUTION NO. 2026-08-1325R

CITY OF TONTITOWN, WASHINGTON COUNTY, ARKANSAS

A RESOLUTION AUTHORIZING THE CITY OF TONTITOWN TO APPLY FOR GRANT FUNDING THROUGH THE ARKANSAS DEPARTMENT OF AGRICULTURE, NATURAL RESOURCES DIVISION, FOR THE HARMON ROAD/WILDCAT CREEK WATER LINE EXTENSION; AND FOR OTHER PURPOSES.

WHEREAS, the City of Tontitown (the "City") has identified the Harmon Road/Wildcat Creek Water Line Extension as a needed improvement to the City's water system; and

WHEREAS, the Engineer's Opinion of Probable Cost for the project is approximately \$846,532; and

WHEREAS, grant funding may be available through the Arkansas Department of Agriculture, Natural Resources Division, to assist with eligible project costs; and

WHEREAS, the final amount of any grant award and the required local match, if any, are not yet known, although preliminary information indicates that the program may require the City to provide up to fifty percent (50%) of the eligible project costs; and

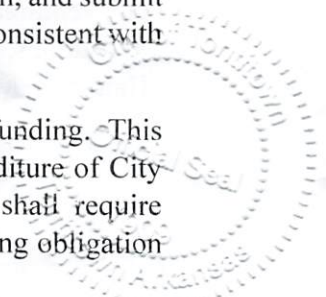
WHEREAS, the City Council finds that submitting an application is in the best interests of the City and its residents, provided that submission of the application does not, by itself, obligate the City to accept an award or provide matching funds.

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY COUNCIL OF THE CITY OF TONTITOWN, ARKANSAS:

Section 1. The Tontitown City Council authorizes and approves the City's submission of an application to the Arkansas Department of Agriculture, Natural Resources Division, for grant assistance toward the project described above.

Section 2. The Mayor and appropriate City staff are authorized to prepare, sign, and submit the grant application and any documents reasonably necessary for its consideration, consistent with this Resolution.

Section 3. This Resolution authorizes only the application for grant funding. This Resolution does not authorize acceptance of a grant award, appropriation or expenditure of City funds, issuance of debt, or commitment of any local match. Any such action shall require subsequent approval by the City Council after the final award terms and local funding obligation are known.



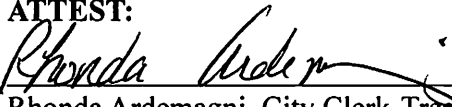
Section 4. This Resolution shall be in full force and effect from and after its passage and approval.
